NOTIFICATION

S.O..... In exercise of the powers conferred by sub-section (2) of section 10 of the Dentists Act, 1948 (16 of 1948), the Central Government, after consultation with the Dental Council of India, hereby, makes the following amendments in Part-I of the Schedule to the said Act, namely:-

In the existing entries of column 2 & 3, against IV of Serial No.60 in respect of Government Dental College and Hospital, Aurangabad, Maharashtra, in Part-I of the Schedule to the Dentists Act, 1948 (16 of 1948) pertaining to recognition of dental degrees awarded by Maharashtra University of Health Sciences, Nashik, the following entries shall be inserted thereunder:-

Conservative Dentistry
(if granted on or after 09.07.2009) MDS (Cons. Dent.), Maharashtra
University of Health Sciences, Nashik"

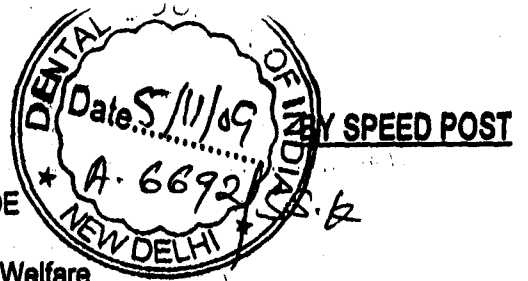


