**Land:** The total area of the college is above 5.0 acres but the Dental College & Dental Hospital are in two different locations separated by a distance of 2 kms.

**Building:** Dental College & Pharmacy College are sharing the same building.

**General Hospital:** The Dental College & Hospital utilizes the 100 bedded Taluk Hospital of the Government for training undergraduate student in basic sciences. It does not have ICU, separate wards for male or female Surgical & Medical. The OT is under repair for three months. It is very rudimentary & poorly maintained. **(All are under renovation)**

**Out patient department:** The outpatient turnover per day is between 20-25 only in the Dental Hospital.

**Hostel:** The Dental College & Hospital, has a common boys and girls hostel for the Dental College & Pharmacy College. The Boys hostel which is in the Hospital campus does not have a mess. Food is bought only from the girls hostel. The Girls are hosted in a working women hostel. Many of the rooms have temporary partitions. There are no recreational facilities for the hostel students. Both the hostels do not have a warden.

**Classroom and Auditorium:** The college has the total of 3 lecturer class rooms with 50 seating capacity. Two are in the Hospital Building & one in the college building. Only one

class has LCD Projection which is not working. There is a common Examination Hall & Auditorium alongwith Pharmacy College in the Dental College campus with seating capacity for 100 students with only minimal provisions.

**Departments:** There are no Satellite Centers. There is no Principal Quarters.

5. None of the staff members have a college Identity Card.
6. Separate Sterilization areas are not present & if present, very poorly maintained.
7. There are no qualified staff nurses in the Dental Hospital.
8. There are no Dental Hygienists in the college.
9. The drainage from the chairs are open and broken in many areas.
10. There is no segregation of Hospital waste.
11. Students & Interns do not have a record with them for making entries.
12. College has no facilities for indoor and outdoor games anywhere in the campus.
13. Ladies Staff Quarters is given in the working women hostel.
14. None of the Departments have Refrigerators to store material.
15. The maintenance of Stock books, Indents needs much to be desired.
  - a. **Oral Medicine:** There is no radiology technician and no records for X-rays taken. The instruments are not AERB certified. None of the staff have Dosimetry bedges. OPG is very old & under repair. The developing room is without requisite instruments and dirtily maintained. No RVG.
  - b. **Oral Pathology:** No histopathology lab available.
  - c. **Orthodontics:** There are no records of patients from 7.3.2018. There is no Cephalometric tracing table or model storage rack. No case maintenance record is done.
  - d. **Pedodontics:** There is no Isolation Room, Play Area. No light cure equipment. No RVG.
  - e. **Prosthodontics:** There is no induction casting machine & no ceramic lab. The only Gas Cylinder is kept inside the department. Equipments are minimal (list) & poorly maintained.
  - f. **Conservative Dentistry:** No RVG//IOPA machine Minimal equipments (list).
  - g. **Periodontics:** Only 2 scalers present in the department. No Dental Hygienist.
  - h. **Public Health Dentistry:** There are no peripheral satellite centres. Mobile van not present. No Museum. No schools are attached. There is no camp activity after October 2017. No Dental Hygienist.
  - i. **Oral Surgery:** Oxygen Cylinder not working very poor sterilization. Open drainage in Minor OT. No qualified Staff Nurse in the Department. Special cases registry not available.
