**Sub:- Furnishing details of registered Dentists in Part 'A' & Part 'B' upto the year 2015 to maintain Indian Dentists Register u/s 18(1) of the Dentist Act, 1948 on DCI's Website.**

Sir / Madam,

I am directed to invite your kind attention to this office earlier letters on the subject cited above, thereby requested to upload the details of Dentists registered in Part 'A' & 'B' on DCI's to maintain Indian Dentists Register. But, despite of repeated reminders for uploading the same has not yet been uploaded on DCI's Website, whereas this Council is under statutory obligation to maintain Indian Dentists Register under Section 18(1) of Dentist's Act, 1948. In this regard, the GOI as well as CAG of India has taken a serious view in the matter.

Further, the Executive Committee of the Dental Council of India in its meeting held on dated 13<sup>th</sup> & 14<sup>th</sup> October, 2016 after discussion and deliberation at length decided as under:-

All the Registrars of the State Dental Councils / Tribunals, be directed to send the up-to-date data of all the existing registered dentists with them in a soft copy (excel file.xls) for uploading the same on Dental Council of India's Website to prepare online Indian Dentists Register and the Members of the DCI under section 3(a) of the Dentist's Act, 1948 also be requested to follow up the same with their respective State Dental Councils.

2. In view of the above, you are requested to kindly send the up-to-date data of the all existing registered dentists (Part A and Part B separately) with your state as on till date in soft copy (excel file.xls) as available (**specifically mentioning the total number of dentists alongwith their details**), so as to enable this Council to compile all the lists of dentists received from all the State Dental Councils in a uniform pattern, to prepare the online Indian Dentists Register.

This may kindly be treated as most urgent.
