

S.O.....In exercise of the powers conferred by clause (b) sub-section (4) of section 10 of the Dentists Act, 1948 (16 of 1948) and in suppression of this Ministry's notification of even number dated 15.5.2007, the Central Government, after consultation with the Dental Council of India, hereby makes the following further amendments in Part - III of the Schedule to the said Act, namely: -

2. Under the existing entries of column 1, 2 & 3 against serial number 87 pertaining to University of Hong Kong, Hong Kong in part - III of the Schedule to the Dentists Act, 1948 (16 of 1948) the following entries shall be added, namely: -
